It is almost the end of your senior year and some of you might still have concerns about what needs to be done and where you will be next year.

**If you have not yet applied to a postsecondary institution or apprenticeship position and you plan to, that needs to be done NOW. We are running into a crucial time in your senior year and it is going to get very hectic. If you are planning on joining the workforce next year you need to be on the lookout for job fairs and openings. The WorkOne office will be able to give you a list of current jobs. You can also contact the WorkOne office about Next Level Jobs and the Work Ready Grant!!

*If you have not filed your **FAFSA** papers do so soon. They must be in the state office no later than April 15th for you to be eligible for state aid. If you miss the April 15th deadline for state aid you can still file for federal aid. Some colleges have an earlier deadline. Make sure you are aware of the deadline for the school you are attending.

*If you are not going to file a **FAFSA** you must sign an opt-out form in the guidance office

* Check your **FAFSA** after it is submitted for errors.

*Students who have not taken the **SAT or ACT** need to do so on the March or April test date (see chart below). It takes approximately 3 weeks to receive scores. Most colleges will not admit you until you have test scores.

Employability Skills– Make sure you have turned in a completed Employability Skills form by Spring Break. I sent emails last week to students who have not completed their form.

FAFSA– Don't forget the state deadline of April 15th. If you will not be filing a FAFSA you will need to sign the opt-out form in the guidance office. There is a federal government delay on FAFSA processing. Processing should start soon.

21st Century– If you are a 21st Century Scholar, make sure you are completing your ScholarTrack activities. Our 21st Century representative will be here April 9th to help students who have questions.

Senior spotlight– If you want to be included in the Facebook Senior Spotlight you have to have a senior picture turned in and the Google form submitted.

Last week of school– Graduation practice will be May 14th. Seniors who need to take finals will take those on May 15th and 16th. Students who do NOT have to take finals will be finished after graduation practice on the 14th.

CAREER CORNER- Law Enforcement

There are many different areas of Law Enforcement. Individuals in law enforcement serve the public, protecting lives and property. They gather evidence and facts to separate the innocent from the guilty. Law enforcement officials also work in correction facilities and prisons.



Average Wage and Salary- this depends on the area of law enforcement
Indiana- Average Salary \$20,000-\$40,000
Nationally- Average Salary \$30,000-\$50,000

Job Opportunities- Individuals in law enforcement can work as: police officers, detectives, correction officers, parole officers, security guards

Who hires law enforcement officials? Local, state and national government, corporations, schools, airports, amusement parks, malls
